

District Parental Involvement Plan

Goal 1: How will the LEA foster effective parental involvement strategies and support partnerships among school, parents, and the community to improve student achievement?

1. Ensure that the buildings will develop and disseminate district parental involvement policy. (August 1, 2015-Becky Foreman)

3. Reserve a minimum of 1% of the Title I, Part A allocation for parental involvement, with 95% going to Title I, Part A schools. (July 1, 2015-Clifford Rorex)
4. Support the coordination of parental involvement activities in each SHS building. (August 1, 2015-Becky Foreman)
5. Establish parental involvement contact person at each of the Title I, Part A schools. (August 1, 2015-Becky Foreman, Ligie Waddell, and Marty Moore)
6. Conduct an annual review of the effectiveness of the parental involvement policy. (May 1, 2015-Becky Foreman and district committee)
7. Develop a district parental involvement committee to create a parental involvement policy and implement parental involvement activities as well as disseminate information to the community to promote parental involvement in the Title I, Part A schools. (August 1, 2015-Becky Foreman)
8. Ensure that parents of children with disabilities or limited English proficiency have the same access as other parents including information in a language and form they can understand. (August 1, 2015-Becky Foreman and Tammy Bradley)
9. Involve parents and guardians in the process of school review and improvement. (August 1, 2015-Becky Foreman)
10. Continue to update the school website with parental involvement information. (August 1, 2015-Becky Foreman)

Goal 2: How will the district provide coordination, technical assistance, and other support necessary to assist participating schools in planning and implementing effective parental involvement?

1. Conduct ongoing site visits to observe parental involvement practices. (August 1, 2015-Becky Foreman)

4. Provide access either online or as a hardcopy of the school policy at each school. (August 1, 2015-Clifford Rorex)
5. Monitor each Title I, Part A school to ensure that each school performs the following tasks:
 - a. Develops a parental involvement policy.
 - b. Provide information to parents about the

school's program, include parent information guide.

c. Develop and use the School-Parent Compact.

6. Encourage parents to visit/volunteer at school by serving as a resource to buildings in developing volunteer opportunities as well as training staff to encourage and build volunteer efforts. (August 1, 2015-Becky Foreman)

7. Support the buildings to convene annual school meeting to inform parents of their school's participation in the development of the parental involvement policy and their right to be involved. Serve as part of the committee. Offer flexible meeting times for parents to discuss any concerns or questions. Provide training ofr parents in working with their child to improve academic achievement. Ensure that parents are aware of the process of the phone notification system and online grading system so that they have access to their child's attendance and academic progress. 4. Develop and disseminate an annual parent activity evaluation report to share with parents, staff, and the community. This report will include results from parent surveys and parent/volunteer logs. The report will be discussed at the first PTE meeting of the year. Provide an opportunity for the parents to assist in the development of the evaluation procedures, including analysis of data collected. (September 2015-Becky Foreman)

1. Recruit parents to serve on district ACSIP committee to develop the Title I Application. (July 1, 2015-Becky Foreman)
