- 6. Encourage parents to visit/volunteer at school by serving as a resource to buildings in developing volunteer opportunities as well as training staff to encourage and build volunteer efforts. (August 1, 2017-Becky Foreman)
- 7. Support the buildings to convene an annual school meeting to inform parents of their school's participation in the development of the parental involvement policy and their right to be involved. Serve as part of the committee. Offer flexible meeting times for parents to discuss any concerns or questions. Provide training for parents in working with their child to improve academic achievement. Ensure that parents are aware of the process of the phone notification system and online grading system so that they have access to their child's attendance and academic progress.
