

Parent and Family Engagement Plan

High School Plan

1. List various communication strategies used in your school to provide additional information to parents and to increase parent and family engagement in supporting classroom instruction.

- Teachers will routinely contact parents on an individual basis to communicate about their student's progress.
- The school will have parent-teacher conferences in the fall at the end of 5 or 6 weeks of school and again in the spring.
- The school will provide to parents reports/report cards every five weeks with information regarding their child's academic progress and upcoming classroom and school events.
- The school will utilize the school reach phone system or send brochures home with students, post notices in school facilities and public buildings, and provide information for local newspapers and radio stations about parent workshops and meetings.

2. List the proposed parent meeting, conferences and activities regularly throughout this year and the dates providing flexible meeting times that you have planned to increase parent and family engagement and build staff and parent capacity to engage in these types of efforts. - The school will have parent-teacher conferences two times throughout the school year; however, all teachers will be available for parent conferences at any time during the year. The teachers will make available scheduled conference times so that parents are able to contact him/her when needed or have concerns involving their child and his/her academic progress.
- Teachers will hold conferences individually with parents of children in their classrooms. Parents will be given a summary of the student's test scores and an explanation of the interventions teachers are using to assist the child in reaching achievement goals. Parents will be asked to engage in discussion of how they can support these efforts. Parents will also be given suggestions for coordinating school-parent efforts and explanations of homework and grading procedures.
- These meetings with parents will be held at various times during the day or evening to better accommodate parents.

3. How will your school provide information to parents about volunteer opportunities (must include state mandated parent training)?

- The school will provide instruction to a parent on how to incorporate developmentally appropriate learning activities in the home environment, including without limitation:

role play and information available through various resources, the use of and access to the Department of Education website tools for parents, and other strategies or curricula developed or acquired by the school district for at-home parental instruction approved by the Department of Education.

- The State Board of Education's Standards for Accreditation of Arkansas Public Schools and School Districts shall require no fewer than two (2) hours of professional development for teachers designed to enhance the understanding of effective parental involvement strategies. No fewer than three (3) hours of professional development for administrators designed to enhance the understanding of effective parent involvement strategies and the importance of administrative leadership in setting expectations and creating a climate conducive to parental participation.
- Our district educational cooperative will provide a Teacher Day each summer before school begins that the teachers will attend to educate them on enhancing parent involvement in the school system.

- School staff, parents, and students will develop a school-parent-student compact. - Parents will be encouraged to attend and participate in the annual Report to the Public meeting.
- To take advantage of community resources, the school alumni created an alumni advisory commission to provide advice and guidance for school improvement.
- The school has developed the formation of a Parents-Teachers in Education organization that will foster parental and community involvement within the school.
- The school will coordinate and integrate parental involvement strategies under other programs.

6. How will your school provide resources for parents?

- Parents may check out materials, use the computer to check grades, and visit educational web sites.

- The school will evaluate the activities that were suggested by the parents at the end of the year as part of the annual parental involvement plan evaluation and consider suggestions for the following year.
